- 1/2020-present: Pain and addiction specialist, Southeast Alaska Regional Health Consortium (SEARHC). Juneau, AK. SEARHC provides healthcare to the Alaska Native population in SE Alaska. Responsibilities include:
  - Direct patient care for treatment of chronic pain and addiction 3-5 days each month.
  - Developing and producing continuing education programs for medical professionals at SEARHC on the topics of pain and addiction.
  - Consultation and telemedicine treatment of patients with chronic pain and opioid use disorder.

  - Educated prescribers about the risks involved with the use of opioids and about more effective ways to treat pain (acute and chronic) than the use of opioids.
  - Helped employers understand the safety risks and increased costs that result from having employees on opioids.
  - Advocated for laws that will reduce the availability of opioids and increase access to treatment for opioid use disorder.
- 3/2020-12/2021: Medical Director, Pieridae Treatment Centers. Hendersonville, NC. This is a methadone clinic for those with opioid use disorder.
- 3/2012-7/2016: Medical Director of Behavioral Health Group – Asheville, NC. This is an opioid treatment program utilizing methadone and buprenorphine for the treatment of opioid use disorder.

  - Advocated for patients: I have met with county, state, and federal leaders to advocate for the needs of our patients.
  - Promoted fundraising by giving presentations to countless civic and church groups.

  - This was a solo practice in Clyde, NC, where I practiced with my wife, Martha, who is a licensed marriage and family therapist and licensed clinical addictions specialist. We

closed this practice at the end of 2007 so that we could both work fulltime at Mountaintop Healthcare and the Good Samaritan Clinic of Haywood County.

- 2004-2008: My wife and I formed a youth group in our church that would do monthly service projects to help needy residents in our community. Generally, this involved construction projects such as building a decks or ramps, installing siding, painting houses, etc.
- 2011: Chairman of the medical committee for “Prescription for Safety”. This was a county task force addressing the issues of abuse and overdose from prescription medications. The death rate from prescription overdose in our county is 3 times the national rate.
